50/50 RAFFLE – OFFICIAL RULES

1. **Eligibility:** The 50/50 Raffle (the “Raffle”) is open only to those who purchase an official raffle ticket (the “Participant”) from an active member of the Midtown Action Council (“MAC”) Board of Directors. Current members of the MAC Board of Directors and their immediate family members are not eligible to participate in the Raffle. Participants must be 18 years of age or older to win and collect a raffle prize. The Raffle is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.
2. **Agreement to Rules:** By participating in the Raffle, you agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein.
3. **Ticket Sales Period:** Raffle tickets will be sold beginning 12:00 AM EDT on Thursday, May 04, 2023 and end at 5:30 PM EDT on Wednesday, June 07, 2023.
4. **Prizes and Proceed Allocation:** The total amount of proceeds collected from the sale of tickets will be allocated as defined in the following table in accordance with the Winner Selection process defined in Item 7, “Winner Selection and Notification.” The total amount of proceeds distributed will depend on the number of raffle tickets purchased during the Ticket Sales Period. A maximum of 500 tickets will be sold during the Ticket Sales Period.

5. **Odds:** The odds of winning depend on the number of raffle tickets purchased during the Ticket Sales Period. A maximum of 500 tickets will be sold during the Ticket Sales Period.
6. **Winner Selection Time and Location:** Winners of Raffle prizes will be selected in a random drawing under the supervision of the MAC Board of Directors at 6:15 PM EDT on Wednesday, June 07, 2023 during MAC’s June Board Meeting held at 1230 N 3rd Street, Harrisburg, PA 17102. Those who purchased raffle tickets may attend the selection at this time and location if desired.
7. **Winner Selection and Notification:** During the selection process, all ticket stubs from purchased raffle tickets will be placed into a single container for random selection of raffle winners by an officer of the MAC Board of Directors (“Ticket Selector”). The Ticket Selector will select a single ticket stub as the “Official Winning Ticket” and the contact written on the Winning Ticket becomes the “Official Winner” of the raffle prize. All remaining ticket stubs will then be sealed in an envelope and stored in a secure location until the prize is claimed by the Official Winner. The Official Winner will be notified via the contact information provided on the ticket stub within five (5) days following the winner selection. MAC shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail, or other security settings or for winners' provision of incorrect, illegible, or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, or fails to claim the prize within 15 days from the time award notification was sent, the prize shall be forfeited, and an alternate Official Winner selected from the sealed ticket stubs. This process will be repeated until the prize is collected by an Official Winner.
